



ENERGY EFFICIENCY TECHNICAL ASSISTANCE FOR THE CARIBBEAN TOURISM SECTOR (Inter-American Investment Corporation (IIC), the Austrian Government, BELTRAIDE)

Two additional workshops were held in March 2009 in the Bahamas and in Trinidad. During all these workshops, the IIC perceived strong interest among SMES in energy audits and in implementing efficiency in their day to day operations. Also, GREENPYME seeks to provide SMES with know-how, tools, and technical and financial support for implementing energy efficiency measures and clean technologies. Doing so will enable these enterprises to become more competitive and sustainable while cutting their energy costs and improving their environmental profile. Enterprises participating in GREENPYME may receive assistance from the IIC for energy audits, consultant support, and technical and viability assessments. Participation in the program may also facilitate access to financing from the IIC itself in the form of loans and equity investments.

Seventeen letters of invitation were sent to SMES encouraging them to participate in the project as potential candidates, only eleven responded to the invitation letters; as such this listing was sent to IIC who will make the final decision concerning which SMES will participate in the actual Energy audits to be made by consultants from abroad. Based on the audit recommendations will be made to the participating SMES on how to reduce their energy consumption, subsequently, financing will be provided by IIC or local commercial banks for the implementation of recommendations made.
