

#### LAND TITLE/LEASE AGREEMENT

- Certified Land Register Report in the name of the applicant company (see *Ministry of Natural Resources*). OR
- Official Lease Agreement in the name of the applicant company and notarized by a Local Notary Public. Also to include the Certified Land Register Report (see Ministry of Natural Resources).

## APPROVAL FROM CENTRAL BUILDING AUTHORITY

• No Objection Letter from Central Building Authority (CBA) in the name of the company seeking the DPA through BELTRAIDE (see CBA).

#### **ENVIRONMENTAL CLEARANCE**

• Department of the Environment (DOE) clearance (with the Executed Environmental Compliance Plan) in the name of the company seeking the DPA through BELTRAIDE (see DOE).
